OTHER PROGRAMS INCLUDE TODDLER PLAY GROUP, STORY TIMES WITH LIVE ANIMALS AND AN AFTERSCHOOL NATURE ENRICHMENT PROGRAM FOR GRADES K-5TH. THE EDUCATORS AT EARTHPLACE BELIEVE THAT CHILDREN'S NATURAL CURIOSITY MOTIVATES THEM TO EXPLORE AND INVESTIGATE BOTH THE CLASSROOM AND OUTDOOR ENVIRONMENTS. OUTDOORS THE STUDENTS PLAY ON THE NATURE-THEMED PLAYGROUND, WALK ON THE TRAILS, INVESTIGATE THE 74 ACRE WILDLIFE SANCTUARY AND VISIT THE OUTDOOR BIRDS OF PREY.
