OTHER PROGRAMS INCLUDE A NURSERY, TODDLER PLAY GROUP, STORY TIMES WITH LIVE ANIMALS AND AN AFTERSCHOOL NATURE ENRICHMENT PROGRAM FOR GRADES K-5TH. THE EDUCATORS AT EARTHPLACE BELIEVE THAT CHILDRENS' NATURAL CURIOSITY MOTIVATES THEM TO EXPLORE AND INVESTIGATE BOTH THE CLASSROOM AND OUTDOOR ENVIRONMENTS.
